## **UMW Debate Tournament hosted by University of Mary Washington**

**[Fredericksburg, VA]** – The University of Mary Washington (UMW) hosted the UMW Debate Tournament on the weekend of Oct. 14 to Oct. 16, 2022. The tournament was attended by 81 teams across the novice, junior varsity and novice divisions.

Debaters from across the country were asked to debate both sides of the season-long resolution about legal personhood in six preliminary debates. The full wording of the topic is “Resolved: The United States should vest legal rights and/or duties in one or more of the following: artificial intelligence, nature, nonhuman animal species.”

Students participating at the tournament debate half of their preliminary debates in favor of the resolution and half of their preliminary debates in opposition to the resolution.

At the conclusion of the preliminary debates, the tournament seeds teams in all divisions based on their win-loss record and speaker points. Elimination debates are single-elimination for the top 16 teams in the novice division, 10 teams in the junior varsity division and 15 teams in the open division.

The Novice division features students who are in their first year of competitive debate. The Junior Varsity division showcases students competing in their first two academic years of intercollegiate debate beyond the novice level.

In the novice division debates, teams from the University of Georgia, Liberty University, Samford University, George Mason University, University of Houston, James Madison University, the Navy, Emory University, Pennsylvania State University, University of Mary Washington and Trinity University competed. George Mason University, Liberty University, Pennsylvania State University, George Mason University, University of Houston, the Navy, Samford University, University of Mary Washington and Emory University were victorious advanced to the octofinals.

In the octofinals, University of Mary Washington, Liberty University, George Mason University and University of Houston were victorious and advanced to the quarterfinals. The UMW Debate Tournament was the second ADA-sanctioned tournament of the year. The next ADA tournament will be hosted by the Wayne State University the weekend of Oct. 21-23, 2022.
